RESOLUTION No. 95-2018

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, OF MARTIN COUNTY, FLORIDA, ADOPTING THE FINAL BUDGET FOR FISCAL YEAR 2019, BEGINNING OCTOBER 1, 2018 AND ENDING SEPTEMBER 30, 2019; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Stuart, Florida, of Martin County, Florida, on September 24th, 2018, held a public hearing as required by Florida Statute §200.065; and

WHEREAS, the City of Stuart, Florida, of Martin County, Florida, set forth the appropriations and revenue estimate for the Budget for Fiscal Year 2019 as follows:

- (a) There is hereby appropriated from the GENERAL FUND of the City of Stuart for the above described fiscal year, the total sum of Twenty-Seven Million, Eight Hundred Nineteen Thousand, Nine Hundred Thirty-One (\$27,819,931) Dollars to provide for the annual budget of the General Fund.
- (b) There is hereby appropriated from the LANDFILL PROPERTY FUND of the City of Stuart for the above described fiscal year the total sum of Forty-Four Thousand, Nine Hundred Twelve (\$44,912) Dollars to provide for the annual budget of the Landfill Closure Trust Fund.
- (c) There is hereby appropriated from the COMMUNITY REDEVELOPMENT AGENCY of the City of Stuart for the above described fiscal year the total sum of One Million, Nine Hundred One Thousand, Four Hundred Sixty-Nine (\$1,901,469) Dollars to provide for the annual budget of the Community Redevelopment Agency Fund.
- (d) There is hereby appropriated from the LEASED PROPERTY FUND of the City of Stuart for the above described fiscal year the total sum of Seven Hundred Eighty-Two Thousand, One Hundred Sixty (\$782,160) Dollars to provide for the annual budget of the Property Management Fund.

(e) There is hereby appropriated from the POLICE SPECIAL REVENUES FUND of the City of Stuart for the above described fiscal year the total sum of Thirty-Eight Thousand, Seven Hundred Forty (\$38,740) Dollars to provide for the annual budget of the Police Special Revenues Fund.

(f) There is hereby appropriated from the WATER AND SEWER FUND of the City of Stuart for the above described fiscal year the total sum of Sixteen Million, Two Hundred Eighty-Six Thousand, Two Hundred Seventy-Eight (\$16,286,278) Dollars to provide for the annual budget of the Water and Sewer Fund.

(g) There is hereby appropriated from the SANITATION FUND of the City of Stuart for the above described fiscal year the total sum of Six Million, Nine Hundred Forty-Seven Thousand, Five Hundred (\$6,947,500) Dollars to provide for the annual budget of the Sanitation Fund.

(h) There is hereby appropriated from the STORMWATER FUND of the City of Stuart for the above described fiscal year the total sum of Seven Hundred Eighty-Seven Thousand, Seven Hundred Eighteen (\$787,718) Dollars to provide for the annual budget of the Stormwater Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, OF MARTIN COUNTY, FLORIDA, that:

SECTION 1: The Fiscal Year 2019 Final Budget be adopted.

SECTION 2: This resolution will take effect immediately upon its adoption.
