



STUART COMMUNITY REDEVELOPMENT AGENCY PAINT-UP PROGRAM

PROGRAM SHORT SUMMARY:

The Stuart CRA Paint-Up Program is a program created to encourage homeowners and residents to repaint their homes. The program provides a voucher of up to 100% (maximum of \$500) per home, toward the cost for painting a home. **The funds will be distributed on a first- come, first-serve basis.**

PURPOSE:

The purpose of this program is to encourage residents to improve the appearance of properties by repainting their homes.

WHO IS ELIGIBLE:

All property owners and residents in the Community Redevelopment Area (see number 1. below) are eligible to participate in the program. For all residents who *do not* own their property, a letter from the owner giving permission to the applicant for repainting the house will be sufficient.

HOW DOES THE PROGRAM WORK:

1. The applicant picks up a Paint-Up Program application from the City Manager's Office or can go online to www.cityofstuart.com, click on Departments, Development, or Community Redevelopment Agency; download the program information, the application and the CRA map to find out if your home is located within the CRA boundary.
2. The applicant brings the completed "application package" to the City Manager's Office, located at City Hall, 121 SW Flagler Avenue. The application package must include the following:
 - Completed Application Form
 - Square Footage (measurements) of the exterior of your property. Take to Sherwin Williams to figure the Cost estimate. The estimate is a part of your complete application package.
 - Paint Color sample/swatch
 - Proof of Ownership of Property (i.e. tax bill, deed to property) or a letter from the owner stating they will allow you to paint
 - Two pictures of front & side of home before paint/ Two pictures after
3. Once staff receives the completed application, we will issue a voucher for the estimated amount (up to \$500.00) to **Sherwin Williams, located at 2880 SE Federal Hwy. Stuart, Florida**
4. The applicant is given 90 days from the date the application is submitted to complete the painting of the exterior of the house.
5. Once the painting is complete, you are required to take (2) *after paint* pictures of the home and submit for your completed paint package.

Applications will be accepted on a first come first serve basis. **The package for the Paint-Up Program must be complete. Before submitting, you will need to go to Sherwin Williams with your home exterior measurements/sq. footage for a printed estimate and paint color swatches. All will be included in your submittal package. Sherwin Williams is located at 2880 SE Federal Hwy., Stuart.**

Check to make sure you have everything listed below to submit.

1. Completed Application Form
2. Sherwin Williams cost Estimate of paint project
3. Paint Sample / Swatch
4. Proof of Ownership of Property (deed or tax bill) or a letter from the owner stating they will allow you to paint the proposed property
5. (2) Photos of property before and (2) photos after paint project is complete
