Characteristics of the Class

Under the supervision of the Team Leader II or superior, performs installation and maintenance of the municipal water distribution and wastewater collection systems. Employees in this class are engaged in the construction and repair of water and wastewater mains and attendant devices. Work includes connection of fittings, excavation for the installation of lines, placement, removal and minor repair to water meters and the testing of water pressure as required. Duties involve exposure to unsanitary wastes and occasional adverse weather conditions.

Illustrative Duties (the following are highlights; a detailed job description is available in Human Resources)

- Installs water and wastewater mains and services; excavates trenches for main placement, installation and repair.
- Raises, lowers and repairs valve boxes; installs water meters; connects and pressure tests fire hydrants; installs stand pipes.
- Assists in locating breaks in utility lines so as to effect repair.
- Assists in repair and replacement of water and sewer lines.
- Operates motor vehicles to transport personnel and supplies to work site.

NOTE: The examples of essential functions as listed in this classification specification are not necessarily descriptive of any one position in the class. The omission of an essential function of work does not preclude management from assigning duties not listed herein if such functions are a logical assignment to the position.

Minimum Qualifications and Education

High School Diploma or GED required.

Licenses and Certifications

Must have a valid FL Driver License. Must be able to obtain a Florida Commercial Driver License (CDL), Class "B" within 12 months of employment. Certification by the Florida Department of Environmental Protection as a Level 3 Water Distribution System Operator required, or the ability to obtain said Certification within 12 months.

Essential Physical Skills and Environmental Conditions

Tasks involve the regular and at times sustained performance of heavy physical tasks such as walking over rough or uneven surfaces, bending, stooping, kneeling, reaching, stretching and working in confined spaces, lifting, pushing, pulling moderate (heavy (25-50 pound) items and occasionally very heavy (100 pounds or over) items. Task involves the frequent use of coordinative and manipulative skills in performing a variety of tasks with the full range of eye-hand and power tools and shop equipment; or the skilled and complex operation of heavy equipment calling for adherence to exacting standards of depth, grade, dimensions, and contours. Task requires that work may be performed in adverse environmental conditions. Task requires sound, odor, visual, color, texture and depth perception and discrimination. Task requires oral communications ability.
