RESOLUTION NUMBER 118-08

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA ADOPTING THE FINAL BUDGET OF THE CITY OF STUART, FLORIDA, FOR FISCAL YEAR BEGINNING OCTOBER 1, 2008 AND ENDING SEPTEMBER 30, 2009; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES..

WHEREAS, it is necessary and proper, to establish the budgetary spending plans (annual budgets) for the various funds of the City of Stuart for the fiscal year beginning October 1, 2008, and ending September 30, 2009, in order to properly reflect anticipated revenues and required appropriations.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA that:

Section 1: The City of Stuart, Florida hereby adopts the final budget, attached hereto, for the fiscal year beginning October 1, 2008 and ending September 30, 2009, as follows:

(a) There is hereby appropriated from the GENERAL FUND of the City of Stuart for the above described fiscal year, the total sum of Twenty One Million, Seven Hundred Fifty Three Thousand, Seven Hundred, Sixty Six (\$21,753,766) Dollars to provide for the budget of the General Fund.

(b) There is hereby appropriated from the LANDFILL CLOSURE TRUST FUND of the City of Stuart for the above described fiscal year the total sum of Sixty One Thousand, Four Hundred, Sixty Eight (\$61,468) Dollars to provide for the budget of the Landfill Closure Trust Fund.

(c) There is hereby appropriated from the COMMUNITY REDEVELOPMENT AGENCY of the City of Stuart for the above described fiscal year the total sum of Three Million, Six Hundred Thirty Thousand, One Hundred, Fourteen (\$3,630,114) Dollars to provide for the budget of the Community Redevelopment Agency Fund.

(d) There is hereby appropriated from the PROPERTY MANAGEMENT FUND of the City of Stuart for the above described fiscal year the total sum Four Hundred Ninety Three Thousand, Four Hundred, Thirty Four (\$493,434) Dollars to provide for the budget of the Property Management Fund.

(e) There is hereby appropriated from the WATER AND SEWER FUND of the City of Stuart for the above described fiscal year the total sum of Eleven Million, Seven Hundred Five Thousand, Fifty One (\$11,705,051) Dollars to provide for the budget of the Water and Sewer Fund.

(f) There is hereby appropriated from the SANITATION FUND of the City of Stuart for the above described fiscal year the total sum of Four Million, Four Hundred Forty Nine Thousand, Five Hundred Eighteen (\$4,449,518) Dollars to provide for the budget of the Sanitation Fund.

(g) There is hereby appropriated from the STORMWATER FUND of the City of Stuart for the above described fiscal year the total sum of Six Hundred Eleven Thousand, Seventy One (\$611,071) Dollars to provide for the budget of the Stormwater Fund.

SECTION 2: This Resolution shall be effective immediately upon adoption.

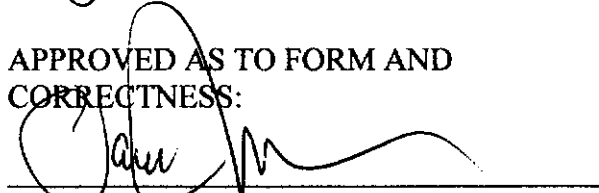

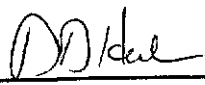

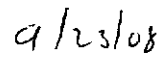
