RESOLUTION No. 133-2017

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, OF MARTIN COUNTY, FLORIDA, ADOPTING THE FINAL BUDGET FOR FISCAL YEAR 2018, BEGINNING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2018; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Stuart, Florida, of Martin County, Florida, on September 29th, 2017, held a public hearing as required by Florida Statute §200.065; and

WHEREAS, the City of Stuart, Florida, of Martin County, Florida, set forth the appropriations and revenue estimate for the Budget for Fiscal Year 2018 as follows:

- (a) There is hereby appropriated from the GENERAL FUND of the City of Stuart for the above described fiscal year, the total sum of Twenty-Six Million, Three Hundred Forty-Three Thousand, Two Hundred Seventy-six (\$26,343,276) Dollars to provide for the annual budget of the General Fund.
- (b) There is hereby appropriated from the LANDFILL PROPERTY FUND of the City of Stuart for the above described fiscal year the total sum of Forty-Eight Thousand, Three Hundred Sixteen (\$48,316) Dollars to provide for the annual budget of the Landfill Closure Trust Fund.
- (c) There is hereby appropriated from the COMMUNITY REDEVELOPMENT AGENCY of the City of Stuart for the above described fiscal year the total sum of One Million, Seven Hundred Fifteen Thousand, Seven Hundred Eighty-Four (\$1,715,784) Dollars to provide for the annual budget of the Community Redevelopment Agency Fund.
- (d) There is hereby appropriated from the LEASED PROPERTY FUND of the City of Stuart for the above described fiscal year the total sum of Seven Hundred Seventy Thousand, Five Hundred Seventy-Five (\$770,575) Dollars to provide for the annual budget of the Property Management Fund.

(e) There is hereby appropriated from the POLICE SPECIAL REVENUES FUND of the City of Stuart for the above described fiscal year the total sum of Forty-Two Thousand, Twenty-Two (\$42,022) Dollars to provide for the annual budget of the Police Special Revenues Fund.

(f) There is hereby appropriated from the WATER AND SEWER FUND of the City of Stuart for the above described fiscal year the total sum of Seventeen Million, Twenty-Nine Thousand, Two Hundred Thirty-Eight (\$17,029,238) Dollars to provide for the annual budget of the Water and Sewer Fund.

(g) There is hereby appropriated from the SANITATION FUND of the City of Stuart for the above described fiscal year the total sum of Four Million, Five Hundred Forty-Seven Thousand, Four Hundred Eighty-Nine (\$4,547,489) Dollars to provide for the annual budget of the Sanitation Fund.

(h) There is hereby appropriated from the STORMWATER FUND of the City of Stuart for the above described fiscal year the total sum of Seven Hundred Seventy-Six Thousand, Six Hundred Fifty-Four (\$776,654) Dollars to provide for the annual budget of the Stormwater Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, OF MARTIN COUNTY, FLORIDA, that:

SECTION 1: The Fiscal Year 2018 Final Budget be adopted.

SECTION 2: This resolution will take effect immediately upon its adoption.
