Characteristics of the Class

Under the supervision of the Team Leader I or Deputy Public Works Director, performs installation and maintenance of the municipal stormwater systems. Employees in this class are engaged in the construction and repair of storm drains, storm pipes and attendant devices. Work includes connection of fittings, excavation for the installation of lines, placement, removal and minor repair to baffle boxes and stormwater systems. Duties involve exposure to unsanitary wastes and occasional adverse weather conditions. *This is a safety-sensitive position requiring screening for illegal substance and alcohol use.*

Illustrative Duties (the following are highlights; a detailed job description is available in Human Resources)

- Installs and services stormwater lines, catch basins, pipes, and grates.
- Assists in locating breaks in stormwater lines so as to effect repair; checks manholes, baffle boxes, and catch basins for blockage.
- Assists in repair and replacement of stormwater lines; assists in the inspection of stormwater lines for defects.
- Operates motor vehicles to transport personnel and supplies to work site.

- Performs general grounds and non-skilled level facilities maintenance and cleaning.
- Operates various heavy equipment and tools.

NOTE: The examples of essential functions as listed in this classification specification are not necessarily descriptive of any one position in the class. The omission of an essential function of work does not preclude management from assigning duties not listed herein if such functions are a logical assignment to the position

Minimum Qualifications and Education/ Licenses and Certifications

High School diploma or equivalent. One (1) year experience in semi-skilled or skilled labor supplemented by one (1) year of experience in the use and operation of moderately heavy vehicles and light to heavy equipment, or an equivalent combination of training and experience. Must be able to lift heavy objects. **Must have a valid Florida Commercial Driver License (CDL), Class "B", or be able to obtain one within 6 months of hire.**

Essential Physical Skills and Environmental Conditions

Involves the regular, and at times sustained, performance of heavier physical tasks such as walking over rough or uneven surfaces, bending, kneeling, stooping, working in confined spaces, stretching, reaching and lifting or carrying moderately heavy (25-50 pound) items and occasionally very heavy (100 pounds or over) items; Tasks involve the frequent use of eye hand coordination and manipulative skills in performing a variety of tasks with the full range of hand and power tools and shop equipment; or the skilled and complex operation of heavy equipment calling for adherence to exacting standards of depth, grade, dimensions, and contours. Tasks may require frequent exposure to adverse environmental conditions. Task requires color, sound, odor, texture, depth and visual perception and discrimination. Task requires oral and written communications ability.
